### Subject: DNC list for cell phones

Dear editor,

Thank you for publishing any and all articles which may help the citizens of Golden better protect their homes and families from no good doers. In some cases, this may even include telemarketers. In Vol.7, No. 3 Golden, Colorado July 2007 of The Voice of Golden, you published an "advisory" on page six (6) titled "Subject: Cell Phone No Call List!", which warned of cell phone numbers being released to telemarketing companies on [or about] July 23. This article included the National DO NOT CALL list phone number and suggested that readers protect themselves from unwanted calls and possibly billing charges by registering their cell phone numbers with this call list.

However, after reading the notice and instructions posted by this registry on the official website, it appears that cell numbers will not be released to telemarketers and it is not necessary to list our cell phone numbers with the DNC registry. Below is the actual webpage from the Federal Trade Commissions website.

### The Truth about Cell Phones and the Do Not Call Registry

Despite Re-Circulating E-mail, It is Still Not Necessary to Register Cell Phone Numbers

As the number of phone numbers on the National Do Not Call (DNC) Registry surpassed 139 million, the Federal Trade Commission today reiterated that despite the claims made in e-mails circulating on the Internet, consumers should not be concerned that their cell phone numbers will be released to telemarketers at any time in the near future. In addition, according to the agency, it is not necessary to register cell phone numbers on the DNC Registry to be protected from most telemarketing calls to cell phones.

The truth about cell phones and the DNC Registry is: Contrary to the e-mail, cell phone numbers are NOT being released to telemarketers, and you will NOT soon be getting telemarketing calls on your cell phone.

There is NO deadline by which you must register your cell phone number on the Registry.

Federal Communications Commission (FCC) regulations prohibit telemarketers from using automated dialers to call cell phone numbers. Automated dialers are standard in the industry, so most telemarketers are barred from calling consumers on their cell phones without their consent.

The national associations representing telemarketers have stated that their clients do not intend to start calling consumers' cell phones.

There is only ONE DNC Registry. There is no separate registry for cell phones. The DNC Registry accepts registrations from both cell phones and land lines. You must call from the phone number that you want to register. If you register online, you must respond to a confirmation e-mail.

While the telecommunications industry has been discussing the possibility of creating a wireless 411 directory, according to the FCC, even if a wireless 411 directory is established, most telemarketing calls to cell phones would still be illegal, regardless of whether the number is listed on the federal government's National Do Not Call Registry.
